As required by the action of the 13th National Convention of The American Legion, the service records of elected officers at Post, County, and District levels must be reviewed and certified to ensure their eligibility for Legion membership and service in an official capacity. The Department of Vermont does this with the completion of the Installation Form. Installation forms can be found at vtlegion.org or contact your District Commander or Department. Posts should be working with their District Commander to schedule your posts installations today. Also, Post Officers are required to submit a DD214 to Department to verify eligibility.

I believe they would be proud of the work we do to improve the lives of youths in our communities. And that dedication can be found not just in April, but every single day on the calendar.

Here are some ways that American Legion Family members can fulfill their commitment to the youth in their communities:

• <u>Register for the third annual</u> <u>100 Miles for Hope</u>, which runs through Sept. 5. Proceeds from registrations and donations go directly to The American Legion Veterans & Children Foundation, which supports our Temporary Financial Assistance program that ensures children of active-duty military servicemembers and Legionnaires are taken care of during an unexpected family financial crisis. As part of 100 Miles for Hope, you can also create fitness opportunities for youths <u>like this</u> <u>post in Virginia did last year</u>.

• Host an arts and craft day, community picnic with relay races

and face painting, organize a nature hike, or help plant a community garden.

• Reach out to the local schools to see if you can teach flag etiquette, share what the flag means and why we recite the Pledge of Allegiance to youth in the classroom.

• Organize a community dinner at the post to raise funds for the Child Welfare Foundation. The CWF has provided more than \$19 million in grants since 1954 to nonprofits that contribute to the physical, mental, emotional and spiritual welfare of the children and youth of this country.

The CPR may be the most beneficial document the post will complete. The post's information, combined with that of other posts, is used when the National Commander and others testify on Capitol Hill as mandated by our federal charter. Each post has a story to tell and when we speak collectively our strength is magnified.. Consolidated Post Reports show the many ways Legionnaires are making differences in their communities and beyond. **Has your Post filled out their consolidated report?** American Legion posts around the world gave millions of hours, raised millions of dollars and influenced millions of lives in 2017 and 2018.

# **DEPARTMENT SERVICE OFFICER**

The American Legion Department of Vermont is seeking applications from candidates interested in this parttime salaried position located at the VA Hospital in White River Junction, VT.

The DSO, who is an employee of the Vermont American Legion, is responsible for keeping a complete file of all laws and VA Regulations pertaining to veterans' benefits and a current file of all veterans for whom the office holds Power of Attorney, and a complete set of applications for benefits received from clients.

The DSO will advise and assist veterans or their dependents presenting claims for disability, compensation, death, insurance, pensions, State and local laws, evaluates and determines validity of claims by reviewing legislation, regulations and precedents and by studying veterans medical reports and service briefs, and will assemble pertinent evidence. The DSO will request hearings before proper government boards and orally presents briefs and reviews board decisions to decide whether an appeal is warranted.

The DSO serves as the Department Child Welfare Director, administers child welfare and rehabilitation funds according to the needs of deserving veterans and their families within the total amount authorized by the Department Finance Committee.

The DSO maintains and makes distribution of grants from the Vermont Legion Family Assistance Fund.

Assists and trains post service officers with current activities and legislation. Participates in post and civil functions such as panel discussions and speeches to inform the public with of services rendered, rights and benefits of veterans and dependents. Supervises and controls the operation of the Department Service office.

The Department of Vermont is an equal opportunity employer and is looking for a critical thinker who is service-minded, trustworthy, and ethical. Will hire for ability and character, and will train for skills. Certification is required upon completion of training.

Interested American Legion members, or veterans who are eligible for membership in the American Legion, should submit a letter of interest, resume and other credentials to: <u>The Department Adjutant, P.O. **PROJECT**

**Project:** To build a permanent structure to house the original chapel bell at the Vermont Veterans Home.

- Goal: To raise \$15,000.00 for this project.
- **History:** The Vermont Veterans Home came into being in 1884. In 1890, a chapel was built entirely with donations from the Grand Army of the Republic. The bell for the chapel was donated by Major A. B. Valentine, a prominent businessman in Bennington at this time.

During the period 1967 - 1976, several renovations and building projects were completed and the original chapel was taken down. A new chapel was built along with a large community room. The Chapel Bell was kept but not built into the new chapel. Instead, it was affixed to a 4' high wooden post structure and parked outside the chapel building. Over the years, the Bell had rusted badly and was in poor condition.



In 2016, the Bennington Rotary Club arranged for the Bell to be refur-

bished. The metal pitting was repaired, and the Bell proper was repaired and resurfaced. However, it still resides atop the 4' wooden posts and is now placed at the memorial area on the Home grounds. This method of display leaves the Bell open to the elements and more evidence of metal pitting and deterioration of the Bell proper is occurring.

**The Plan:** The project entails the Bell being removed from the wooden posts and placed in a permanent structure that would protect it from the elements and place it on display with a plaque giving the history of the Chapel Bell.

The structure will be placed in the grassy area just in front of the main entrance of the Veterans Home and resemble the original architecture of the Veterans Home.

The Bell would be hung inside the structure rather than set on a base.

A stamped concrete walkway would lead to the Bell display with a wrought iron fence around the structure.

Local contractors have already been contacted and have signed on for the project.

# PathwaysVermont 2021 FACT Supportive Services for SHEET Veteran Families

In partnership with



The Supportive Services for Veteran Families (SSVF) program is a national initiative funded by the Department of Veterans Affairs to address homelessness among veterans in the United States.

The SSVF program is housed in Vermont Veteran Services at the University of Vermont, with case management and housing services provided by Pathways Vermont. The program helps very-low income veteran households who are homeless or imminently at risk of homelessness gain and retain stable housing.

Services provided include needs assessment, intensive housing case management, assistance accessing VA benefits and financial assistance.

#### PROGRAM SERVICES

The Supportive Services for Veteran Families program provides short-term supportive services to participants to help them obtain and/or retain stable housing in 90 days. The program uses a Rapid Rehousing approach, meaning the program's priority is to support participants in developing a permanent housing option.

Intensive case management is the primary service provided. In certain cases, case management may be augmented by temporary financial assistance. This assistance is used to help with expenses related to securing housing, for example rental assistance, security deposits, utility deposits and other related expenses. It should be noted that financial assistance is limited in amount and cannot be guaranteed.

#### FY22 FUNDING

In 2014 Pathways Vermont was awarded a subcontract from SSVF at UVM to provide case management and housing services for a Supportive Services for Veteran Families grant awarded by the Department of Veteran Affairs. The SSVF program operates in all 14 counties in Vermont and 6 counties in the eastern Adirondacks. We have to raise \$15,000 to cover expenses that the grant does not cover.
