








2nd District Commander – Roy McKinnon





As a military retiree and combat veteran, I am disappointed to learn of your lack of support for the S.16 and H.43, bills that would exempt military retirement income from Vermont state taxes. I ask that the bills proceed from their respective committees and be brought to a vote by the Senate and House. From my perspective and the perspective of many of my fellow Vermont veterans, allowing the bills to "die" in committee is far worse than these bills falling short in a Senate or House vote. I've reached out to my Waterbury representatives (Cc'd on this message) in the email below asking for their support. Unfortunately, neither representative would commit to supporting H:43 without any "strings" attached. Please allow these bills to come out of committee and proceed to a vote. If you truly support the military and value the service of veterans, you would not hesitate to bring these bills to the House and Senate for consideration.

Oratorical - Karlene DeVine

Department of Vermont American Legion held its 74th High School Constitutional Speech contest concluding with the winner, Hadley Butler taking first place Sat. Mar. 22. Her speech, "Our Duties," challenged the audience to rethink a citizen's duties and responsibility towards military recruiting. Reflecting a rise in patriotism immediately after 9/11, recruiting was at its highest twenty-four years ago. Weighing in with multiple factors, none of the Armed Services are now meeting their recruiting goals.

This American Legion High School Constitutional Speech Contest was developed primarily to instill a better knowledge and appreciation of the U.S. Constitution in high school students. The research and development of preparing for this contest supports development of leadership, the ability to think and speak clearly and prepare for the duties, responsibilities, rights, and privileges of American citizenship.

Each contestant speaks for 8 to 10 min. in a Prepared Oration on some aspect of the U.S. Constitution and a citizen's duties and responsibilities. The contestants do this without using notes, a microphone, or a podium.

An Assigned Topic, based on one of 4 Amendments, is the subject of a 3 to 5 min. oration addressing a citizen's duties and responsibilities. This is randomly selected 5 minutes before the student is to speak. The 4 Amendments are chosen by National American Legion and published in May.

Sponsored by Montpelier American Legion Post 3, Butler received \$1500 and will represent Vermont at the American Legion National Finals May 16-18 at Hillsdale College, Hillsdale, MI. She will vie for one of the top three prizes, \$25,000, \$22,500 or \$20,000.

Butler is a sophomore at Green Mountain Valley School and lives in Waitsfield with her mother, Sarah Butler. At school, she participates in alpine skiing, student government, theater, soccer, and lacrosse. Participating in this speech contest last year inspired her to attend a military camp for teens last summer. She will attend the American Legion Auxiliary Girls State this coming summer.

The 2025 Vermont Department contest was held at the Conference Center at the VA Medical Center, White River Jct.

Additional contestants, McKinley Keaffaber, a junior at Mt. Anthony Union High School, took second place for \$750. "The Constitution, What Does It Mean Today?" was Keaffaber's Prepared Oration. He is sponsored by Bennington American Legion Post 13. Keaffaber's

extracurricular activities include varsity golf, the National Honor Society and several other speech and debate competitions. Keaffaber lives with his parents, April Scott and Drew Keaffaber.

Nolan Ross, home schooled and a sophomore at Champlain Valley Union High School (CVUHS) received \$500 for third place. The title of his prepared Oration was "What Are Your Duties and Why You Should Perform Them?" He was sponsored by American Legion Colchester Post 91. Ross has been on the public forum debate team at CVUHS and decided to step out of his comfort zone to participate in the American Legion speech contest. He lives with his parents Gretchen and Steve Ross in Williston.

All orators spoke on Amendment XXVI. Ratified in 1971, it lowered the voting age to 18, ensuring that citizens 18 years and older cannot be denied the right to vote based on age. The Amendment's primary goal was to address the "old enough to fight, old enough to vote" argument when young men were being drafted at 18 for the Vietnam War, but could not vote until they were 21, thus being deprived of the opportunity to have a say in a political decision that impacted their lives.

One perspective suggested lowering the voting age to 17 so youth would have peer, family and community support at the time of voting-before graduating from high

school. Some statistics show that if one does not vote at age 18, there is a strong indication that that individual will not vote again for several years. Another perspective was to put more emphasis on civics in secondary schools.




