## Not just Walter Reed

Dear American Legion Family Members and Friends,

The report by the Navy Times hit like a gut punch. No hot water, A/C or doors with locks for junior troops forced to live in hellish Walter Reed base barracks was the headline of the article published on Feb. 4.

In essence, nearly 500 Navy corpsmen and Army medics stationed at Naval Support Activity Bethesda were housed in quarters with insufficient hot water, broken locks, inoperable air conditioning and other “trouble ticket” items that even the commanding officer admits have existed for years. It is no small irony that the two barracks were named Comfort Hall and Sanctuary Hall.

Fortunately, leadership at the facility has started relocating more than 350 of the servicemembers to temporary lodging and initiating the needed repairs.. But still, one has to wonder how did we get to this point? In 2007, the Washington Post reported mold and rodent infestations in Building 18 at the old Walter Reed Army Medical Center. In 2021, a congressional delegation toured a barracks at Fort Hood which was described as “the worst they’d ever seen.” Military.com reported a similar situation at Camp Lejeune.

When the media exposed a wait-time and records manipulation scandal at a VA Medical Center in 2014, The American Legion loudly proclaimed that the problem was “not just Phoenix.” Subsequent inspector general reports and congressional hearings proved us right.

I hope that history is not repeating itself with military housing.

The sixth of the 11 Principles of Military Leadership is “know your people and look out for their welfare.” Every military commander should take it to heart. Infrastructure has been one of the most used Washington buzz words for the last year, yet I can think of no infrastructure project more worthy than providing quality housing for our military members.

Veterans have endured many hardships while serving in war zones. But garrison living should be different. The men and women who choose to serve in our all-volunteer force have many other attractive options. They should not be subjected to living in third-world conditions while serving in a first-world nation. The military of 2022 should not expect its members to live in housing that hasn’t been adequately renovated in decades. Next month, I will address a joint committee of Congress. You can bet that this will be a major topic of discussion.

## SENIOR VICE COMMANDER

I have heard legionnaires ask, “What are the National Commissions and Committees all about” and “what can individuals from a Department contribute on a national level?” I will try to put a little clarity to it through my own experience.

There are various Commissions (Americanism, Convention, Finance, Internal Affairs, Legislative, Marketing, Media & Communications, Membership & Post Activities, National Security, Special, Veterans Affairs & Rehabilitation, and Veterans Employment & Education), and many of which have various committees under the same. I was formerly a member of the Law and Order & Homeland Security Committee which is under the National Security Commission. My three decades in law enforcement and retiring as an executive in that field from a major law enforcement agency enabled me to make viable recommendations and decisions.

My most recent appointment is to the Veterans Employment and Education Commission. At the most recent convention in Phoe-

nix I attended the commission meeting and there were excellent presentations, particularly in the area of veteran’s employment. The two that particularly interested me were from the CEO’s of Hiring our Heroes, a project of the U.S. Chamber of Commerce, and SkillMil. They work at placing veterans into the workforce, particularly those exiting the services. Both function in different ways, for example, SkillMil utilizes the military occupational specialties and other credentials to include non-military to connect veterans to jobs.

As a result of these presentations, and the fact that my son-in-law had recently told me he currently needs over 1,000 employees, and it will rise to over 4,000 with the infrastructure bill passing, I saw the potential in getting all of them aligned and connected, working to put veterans in the front of the line for jobs.

My son-in-law is the International Servicing Director for the International Union of Painters and Allied Trades (IUPAT). They do commercial/residential painting, industrial/bridge painting, dry-wall finishing, glazing (glass structures), to include the painting of military facilities and vessels, both inside and out. They also have training centers in eve-

ry state and some of the jobs, particularly work on military installations require clearances. Bridge painting, for example, is a job that requires training and certification, and is highly paid work. With the passing of the Infrastructure Bill there will be an increased need for individuals to fill these types of positions.

I was able to get them all connected and they have all met and are working on plans to get our veterans good paying jobs. A positive result helping our nation’s heroes. I am proud to have played a little part in the solution to the problem of veteran’s employment.

Being on a National Commission or Committee has to be taken seriously so as to effect positive outcomes. It is not just a check in, and *check out*.

Back in July ~ September 2021 I was at the VA and in the planning stage for having knee replacements. When they did the pre-op testing they found my blood counts to be abnormal. They sent me to Dartmouth-Hitchcock Medical Center where I received the diagnosis of acute myeloid leukemia (AML). This is a chronic leukemia which requires treatments for extended periods now and into the future because this cancer leaves a residue of cells that can not be detected. So... treatments must continue regularly.

As we Christians do, I immediately asked God to take my burden. I am confident that God will get me through this. There have been some other bumps in the road as well, such as pseudo-gout in my

knees and blood clots in my left leg and right lung. He has held my hand every moment and has His Angels: doctors, nurses, specialists, as well as family, friends and neighbors who have called, sent cards, and prayed for me. Praise God for all these very special folks.

I am very weak due to the cancer infusions and all the medicines, but getting around with a walker or wheelchair. God has me on a positive ramp to become fully restored and in good condition. He is awesome. Sometimes, there is no strength to stand up, that's where God adds his strength to stand and off we go. Even in discomfort and pain, God's presence and strength leaves me with a sense of joy and peace.

Enough about me, sure miss getting around to some of the Posts and attending the special activities. Can't tell you how much I appreciate the prayers, cards, and calls. My apology for not getting the

word out much sooner. We've been on a roller coaster without breaks. We have been traveling to Dartmouth-Hitchcock Medical Center, Rutland Regional Hospital, Southwestern Vermont Medical Center, and the White River Veterans Hospital. All of these places have God's Angels taking great care of me. There are many times when I have had no strength; that's when God's strength comes along and lifts me up. Praise the Lord.

Hey Posts and individuals, if you haven't made a donation to the Commanders Bell project at the Vermont Veterans Home, please consider doing so. It means so much to me to know that the old Chapel Bell will no longer deteriorate. God bless you for your support. Please remember to pray for our troops.

There you will find step-by-step instructions and how-to videos covering the most common features utilized by individual members and membership processing features for posts.

### How to Use MyLegion.org.

Our IT staff is continuing to update the MyLegion platform to add features and resolve issues. The progress of these improvements may be found under "Known Issues." **Known Issues (mylegion.org).**

I'd like to give a special thanks to the Middlebury American Legion Post 27 for their support to the Dodge House. Middlebury Legion Family members hosted an on-site radiothon fund raiser with WVTM radio station at the Post home, which with matching funds from the Post, raised another \$15,000.00 for the program. At the event, Commander Revell signed up a new SAL member, JT Dodge, the son of Mike Dodge, who the house is named for. As you can see, job one, membership is instilled into the leadership of the Sons, with a mission to go beyond our goals. To date, we have achieved over 2,800 members reaching 78+% of goal. - In July the Sons of the American Legion made a sizeable donation to the Vermont American Legion Foundation
- In the last part of July and early August the American Legion Baseball season ended with Post #91’s team taking the winner’s trophy in the post season tournament
- In August our leaders attended the 102<sup>nd</sup> National Conference in Phoenix, Arizona
- In September a solemn remembrance of the tragic events of 9/11 was held at Middlebury at Post #27
- The National President of the American Legion Auxillary, Kathy Daudistel, visited our State in September
- Also in September the Dept. Commander installed a new slate of officers at Norwich University Post #1819

- In October, the Dept. Commander installed the officers of Thetford Post #79

- In November, a Civil War memorial rededication ceremony was held at the Bennington Museum; this was in many ways the work of Bennington Post #13

## Mission Blue Grants

All Mission Blue Applications must be submitted before July 1, 2022, for those posts to be awarded grants. Internal Affairs will be unable to process any grant applications after this date.

Since Fall Meetings, national has made it easier than ever for posts to receive at least a portion of the maximum \$2,000 available for these grants. If a post does not have either a current CPR on file or insurance with national listed as an additional insured, they could still be eligible to receive

up to \$1,000. If those posts can secure the proper insurance requirements afterwards, they may reapply for another \$1,000 (or whatever amount meets the maximum amount for Mission Blue grant totals.) Posts that have previously received \$1,000 under the former requirement restrictions can be eligible for the remaining amount of the \$2,000 maximum so long as they have a certificate of insurance for a current policy at the time of the second/ subsequent application(s).

Additionally, all recipients' posts are required to submit a grant usage report within six months of the check issued date per the

terms of the Mission Blue Grant program. Posts that do not report their grant usage potentially be billed by finance for the entire amount of those funds. As of today, approximately 60% of all grants issued have been reported and 86 reports are overdue. Please reach out to all your overdue recipient posts and encourage them to submit their report to avoid an awkward situation. We do not require receipts and the form takes no more than 2 minutes to complete.

# DEPARTMENT COMMANDER'S PROJECT

*Preserving a piece of the  
Veterans Home history*

**Project:** To build a permanent structure to house the original chapel bell at the Vermont Veterans Home.

**Goal:** To raise \$15,000.00 for this project.

**History:** The Vermont Veterans Home came into being in 1884. In 1890, a chapel was built entirely with donations from the Grand Army of the Republic. The bell for the chapel was donated by Major A. B. Valentine, a prominent businessman in Bennington at this time.

During the period 1967 - 1976, several renovations and building projects were completed and the original chapel was taken down. A new chapel was built along with a large community room. The Chapel Bell was kept but not built into the new chapel. Instead, it was affixed to a 4' high wooden post structure and parked outside the chapel building. Over the years, the Bell had rusted badly and was in poor condition.



In 2016, the Bennington Rotary Club arranged for the Bell to be refurbished. The metal pitting was repaired, and the Bell proper was repaired and resurfaced. However, it still resides atop the 4' wooden posts and is now placed at the memorial area on the Home grounds. This method of display leaves the Bell open to the elements and more evidence of metal pitting and deterioration of the Bell proper is occurring.

**The Plan:** The project entails the Bell being removed from the wooden posts and placed in a permanent structure that would protect it from the elements and place it on display with a plaque giving the history of the Chapel Bell.

The structure will be placed in the grassy area just in front of the main entrance of the Veterans Home and resemble the original architecture of the Veterans Home. The Bell would be hung inside the structure rather than set on a base.

A stamped concrete walkway would lead to the Bell display with a wrought iron fence around the structure.

Local contractors have already been contacted and have signed on for the project.

# SON's Commanders Project

## Pathways Vermont Supportive Services for Veteran Families

### 2021 FACT SHEET



The Supportive Services for Veteran Families (SSVF) program is a national initiative funded by the Department of Veterans Affairs to address homelessness among veterans in the United States.

The SSVF program is housed in Vermont Veteran Services at the University of Vermont, with case management and housing services provided by Pathways Vermont. The program helps very-low income veteran households who are homeless or imminently at risk of homelessness gain and retain stable housing.

Services provided include needs assessment, intensive housing case management, assistance accessing VA benefits and financial assistance.

#### PROGRAM SERVICES

The Supportive Services for Veteran Families program provides short-term supportive services to participants to help them obtain and/or retain stable housing in 90 days. The program uses a Rapid Rehousing approach, meaning the program's priority is to support participants in developing a permanent housing option.

Intensive case management is the primary service provided. In certain cases, case management may be augmented by temporary financial assistance. This assistance is used to help with expenses related to securing housing, for example rental assistance, security deposits, utility deposits and other related expenses. It should be noted that financial assistance is limited in amount and cannot be guaranteed.

#### FY22 FUNDING

In 2014 Pathways Vermont was awarded a subcontract from SSVF at UVM to provide case management and housing services for a Supportive Services for Veteran Families grant awarded by the Department of Veteran Affairs. The SSVF program operates in all 14 counties in Vermont and 6 counties in the eastern Adirondacks. We have to raise \$15,000 to cover expenses that the grant does not cover.

PDC Ferris brought up whether we can use a larger facility such as an armory or the auditorium. PNVC Perham was concerned about the limited parking. The Barre site is on hold until further information is obtained. Next mid-winter, 2023, to be held at the Doubletree in South Burlington was moved and passed.

New business was then brought up. Post 35, Mt Mansfield is up and running well.

Commander Tester then made appointment of Barb Bushaw as the Americanism committee chair.

Resignation of DSO was then brought up. PNVC Perham moved not to accept the DSO resignation. Moved and passed to go into executive session. Voted to come out of executive session. Vote on motion to not accept DSO resignation failed.

PDC Latour moved that the DEC accept the DSO resignation. Motion passed.

The meeting was adjourned at 1515 hours.
