National Association of Department Historians of the American Legion

As the New Year begins to unfold it is worth a paragraph or two to introduce the leadership of the National Association of Department Historians of the American Legion (NADHAL). The two principal leaders at the national level are the National Historian, Deborah Davis, and the president of the NADHAL Charemon Dunham.

Deborah Davis was born and raised in Denver, Colorado. She joined the Army in 1975 and retired twenty-two years later in 1997. She has a BA in History from the University of Colorado. As a Legionnaire she has had the distinction of having served three years as the post

commander of the first all-female post in Colorado. One of her principle missions this year is to flesh out, test and deploy a set of ground rules for the submission of fully digital history books. This year the judging team will accept one digital history book from the Department and one from a Post within the Department. These will be used to test the judging rules to be implemented and included in the 2023 Officers Guide.



The President of the NADHAL is South Dakota Legionnaire, Charemon Dunham. M.s Dunham is also an Army veteran having served as a Personnel Officer (Captain). She was previously the President of NADHAL from 2005-2007 and she served as the National



Historian from 2013-2014. She advises all American Legion Historians that "Histories are important. If we do not write up our history or do not take pictures, our history is lost. Memories fade and verbal stories change. [The Historian] is the one who will make sure our history is not lost...if we do not document our history, we will regret it."

American Legion National Commander Vincent J. "Jim" Troiola will award his national commander "Be Then One" membership excellence pin to any Legionnaire who obtains three new members into The American Legion.

A new member is any eligible person joining for the 2023 membership year who was not a member of The American Legion during the 2022 membership year. Transfers do not count as new members. Each member listed must be eligible for membership in The American Legion. Forward names of Sons of The American Legion members or Auxiliary members to your squadron or unit for use in their respective incentive programs. Only one pin will be awarded per individual. Upon receipt, national membership staff will confirm the names in the national database and mail the pin directly to the person who earned it.

As we enter The New Year, I know I speak for Commander Revell, and all of the Detachment of Vermont Sons members, who would like to wish all of our veterans a happy and healthy 2023. In addition, we commit to continue our service and care to all of our honored veterans, who have served our great nation. As you all know, The Sons exist for the purpose of honoring our veteran's service and to give aid and support for all the great programs for which help lift up our veterans, their families, and the communities in which we live. I speak to all of the Officers of our Department's Legion Post with SAL Squadrons. You have a valuable asset right in your Post. With proper support and guidance, you can achieve greater levels with dedicated Son's members ready to help in any and all Post functions. Give them the tools they need to assist you in becoming a full family partner in service to our Veterans. You can start by naming an active working Advisor. I promise you that positive results will follow. If you do not have a SAL Squadron charted in your Post, I encourage you to contact me for all of the reasons I have stated above. Why not make your Post a true Legion family?

I want to congratulate the Detachment on their membership efforts. As of this writing, we are setting at 68 percent, slightly better than the 60 percent January 19th benchmark goal. American Legion Brand

When it comes to designing products for American Legion events and programs, National Headquarters has developed a style guide to help you create designs that match our existing brand and brandmark. This guide walks you through color, font and layout specifications among others. It also will walk you through when to use the emblem versus the brand mark. To access the style guide visit legion.org/brand.

The brand mark is to be used in all marketing communications applications (e.g., lifestyle apparel, fundraising, sponsorships, digital media, social media and event announcements). While the emblem should be reserved for official documents and communications (e.g., press releases, business cards, post signage and official letterhead).

The American Legion emblem and other legally protected logos of the American Legion Family is restricted and typically may not be used without permission from National Headquarters.

The use of the emblem by an individual Legionnaire is limited to the wearing of the official insignia and to the possession of authorized jewelry or merchandise bearing the insignia. Posts are confined to using the emblem or reproduction of the emblem on stationery, post publications, notices, posters or place cards, or matters of similar character used in the ordinary routine and conduct of legitimate post business. Departments are similarly limited.

Any other use of the name "The American Legion" or the emblem shall be subject to the approval of the national adjutant at <u>legion.org/emblem/request</u>.
