2023 Membership Dues Renewal Notices

FROM: Tom Scanlon, Department Commander

I am sure most of you have received calls from our membership concerning the 2023 dues renewal notices recently mailed out by National Headquarters. I have dealt with these calls as has our Department Headquarters. The problems are centered on the statement "Member Since 2022" on the front of the notice and on the reverse, the sample, with the members name printed on the same has the number "1" for continuous years. Like notices were mailed from National HQ to Paid Up for Life (PUFL) members as well. PUFL members should not be even getting a renewal notice.

Rest assured that no member has lost any of their consecutive years. The 2023 cards as received have the accurate information on the same for all members and these are in the process of being distributed from Department HQ. Being a Post Adjutant I checked on My Legion as to the records of post members and found them to be accurate with the proper consecutive years for the sample I checked.

National HQ is aware of this problem in that they have been flooded with calls from both members and Department Headquarters from across the country. They are addressing the cause of this problem and will attempt to correct the same as quickly as possible. Someone made an unbelievably unwise decision of how to format a renewal notice.

Once again, please advise all your members that they are not and will not be losing any consecutive years. Additionally advise them that they can renew online at <u>www.legion.org/renew</u> and at that time of renewal they can check their online information without needing to login.

I apologize to all on behalf of our National HQ for this erroneous and misleading notice being sent out, and please rest assured that the Department of Vermont has voiced its concern on this issue.

988 Suicide Crisis Hotline launches July 16

The Suicide Prevention Lifeline's new three-digit dialing code will go live nationwide on July 16. People experiencing a mental health crisis will be able to call 988 and connect to counselors with the National Suicide Prevention Lifeline network. Advocates believe that designating a three-digit telephone number will transform access to mental health care. The three-digit number is easy to remember, which should make it faster for Americans dealing with a mental health crisis to receive life-saving support.

VA Burn Pit Registration

Veterans and Service members who have deployed to the Southwest Asia theater or operations on or after August 2, 1990, as well at those who have deployed to Afghanistan or Djibouti after September 11, 2011 can use the registry. For assistance with registering call 888-607-8773.

Past Department Commander Francis Killay

June 26, 1941 – June 23, 2022

Francis "Frank" John Killay, 80, of Groton, VT passed away unexpectedly on June 23, 2022.

Frank was born on June 26, 1941 in Athol, the son of James and Frances (nee Lawsky) Killay. As a teenager Frank was mentored by his brother and best friend, Jim, who introduced him to the pursuits of hunting, fishing, and bird dogs, which became lifelong pleasures.

After graduating from Athol High School in 1959, Frank went to work for the L. S. Starrett Company where he completed their apprentice program, becoming an accomplished tool maker.

In 1964 Frank entered the United States Army and was assigned to a Military Police Company, and so began his



law enforcement career. He was honorably discharged as a Specialist 4th Class.

In 1968 Frank applied to and was accepted at the Vermont State Police Academy at Norwich University in Northfield, VT. For several years Frank was stationed at the Bellows Falls and Rockingham Barracks. He was then assigned to State Police Headquarters in Waterbury, where he advanced to detective in the Forensic Crime Lab. He was schooled at the Red Stone Arsenal for EOD training, and worked in the Haz Mat Division. Frank was also an expert in Ballistic Science.

Frank retired in 1991 from the Vermont State Police as a Lieutenant, completing 25 years of service.

A passionate advocate for veterans, Frank was a past Commander of the American Legion Post #3, and as Sargeant of Arms he served over 30 years with the color guard. In addition, Frank held various positions in the Legion statewide and participated in conventions all over the U.S and Canada.

Frank is survived by his brother, James (Jim) Killay and his wife Karen of Templeton, his companion Archola (Archie) Harlow and her daughter, Debbie, and special friends, Dick Harlow, Mike Keough, and Rick Gray, along with his many friends from the American Legion Post #3.

A memorial service with military honors was held at the Vermont Veterans Memorial Chapel in Randolph, VT. Tom Harty, Frank's longtime friend, said the eulogy. The American flag was presented to Frank's brother, Jim. Burial was in the Randolph Veterans Cemetary.

Past Department Commander Milton A. Willis

March 17, 1948 – June 1, 2022

Milton A. Willis Jr., 74, of Chester, passed away peacefully on June 1, 2022, at home with his loving wife and family by his side.

Milton was born March 17, 1948, in Newport to Milton and Margaret (Cota) Willis. He graduated from North Troy High School in 1966 and immediately started to work for his Uncle Floyd, who taught Milt the carpentry trade for many years. Eventually Milt went on to own and operate his own business in the North Troy area for several years. Milt believed in giving back to the community and became a member of the North Troy Volunteer Fire Department and was one of the founders of the Missisquoi Valley Ambulance Service.

Milt joined the North Troy American Legion Post 28, serving as commander for many years It was here that Milt discovered his true-life passion of advocating for fellow veterans. Milt held many positions in the American Legion from the local post, the American Legion Department of Vermont and at the national level.

During his tenure as department commander, he appointed himself as department service officer, a position he held for the next 37 years, until his retirement in 2021. During those 37 years, Milt helped thousands of veterans at the VA and quickly gained respect as chairman of the Department Legislative Committee. While in this position, he lobbied endlessly for U.S. veterans and his colleagues nationwide. Milt became the "go-to service officer" for colleagues across the nation and was elected president of the Department Service Officers for two years.

Milt chaired many committees at the department level but was most proud of his Department Legislative chairmanship. During this time, he tirelessly lobbied and was instrumental in the creation of national legislation allowing veterans throughout the United States to be better served. Milt collaborated with many dignitaries, including U.S. Sens. Patrick Leahy and Bernie Sanders, who Milt considered close and personal friends.

Milt also held chairmanships at the national level consisting of Alt. National Executive Committee, the Naval Affairs Committee, National Executive Committee, member of the Commission on Children & Youth Liaison Committee, vice chair of the Distinguished Guests Committee, Region 1 member on the Veterans Affairs & Rehabilitation Commission, Region 1 member, vice chairman and chairman of the Veterans Affairs & Rehabilitation Commission, and a member of the Veterans Benefits Committee.

Family meant everything to Junior (as he was known by family). He was only a phone call away if his parents, siblings, children or grandchildren were in need. He relished being an uncle and grandchildren were an added joy to his life.

Fishing, celebrating birthdays, holidays with his family, camping, barbecuing, dancing, country music, playing the spoons, hunting, snowmobiling and listening to the Red Sox on the radio and watching the New England Patriots were his favorite past times. But he was happiest when all



of his family was around. Milt made it known that he felt blessed to have three families, one in the Northeast Kingdom, Chester and, of course, the American Legion.

Milton is survived by his wife Sue of Chester, his children: Penny (Scott) Martin; Tim (Donna) Willis of Derby; Beth- Anne Willis of North Troy; Meaghan Willis (Ryan) of Colchester; and Samantha Willis; and stepchildren Shannon; Kyle and Sierra Kemp and Lindsey Sturtevant, all of Chester. He is also survived by grandchildren Rodney; Macy; Greg (Mya); Tim JR; Emily; Lily; Samuel; Maddox; Halley and Owen, and by three great-grandchildren, Weston, Hailee and Beckett. Milton is also survived by his sister Linda Driver (Everett) of Newport Center; his brother Danny Willis of Tucson, Ariz.; mother-in-law Carol Ploof of Lehigh Acres, Fla.; and many special nieces and nephews.

Milt was predeceased by his parents Milton Sr. and Margaret Willis; brother Neil; father-in-law Bob Ploof and two grandchildren Brianna and Michael, who surely were waiting for him to come home.

A Celebration of Life will be hosted by the Chester American Legion Post 67, at 2 p.m. on Sunday July 31. Milt loved his cowboy boots. Please feel free to wear your favorite western duds, in his memory. A private burial will be held at the Troy, Vermont, Cemetery at the convenience of the family.

Temporary Financial Assistance

Since its establishment in 1925, The American Legion Temporary Financial Assistance (TFA) program has awarded cash grants to minor children of current active duty or American Legion members. These grants help families in need meet the cost of shelter, food, utilities and health expenses, thereby keeping the child or children in a more stable environment. <u>Download the TFA Brochure</u> or at bit.ly/TFA_pamplet

Who is eligible for a grant?

The minor child must not be older than 17, or 20 if still enrolled in high school or is physically handicapped. The minor child must be the biological child, stepchild, or in the legal custody of, a qualifying veteran. A qualifying veteran is defined as a member of the United States Armed Forces serving on federal orders current under Title 10 of the United States Code, inclusive of all components, OR any veteran possessing an up-to-date membership in The American Legion. Active-duty applicants can be considered without being a member of The American Legion. A single onetime non-repayable Temporary Financial Assistance grant of up to \$1,500 will be permitted for the minor child(ren) of a qualifying veteran.

No child is considered eligible for Temporary Financial Assistance until a complete investigation is conducted at the post or department level, a legitimate family need is determined, and all other available assistance resources have been utilized or exhausted. Additionally, the TFA application must originate and be filled out by someone at the local level.

Dept Commander Tester discussed DSO applications.

SAL Adviser Paquin brought to DEC's attention that he had heard that North Troy Post wanted to turn in their charter. Concern about the SAL members status. Northern Area Cdr mentioned that the Post has closed its doors and were not responding to queries about their status. Said IA will be looking into this issue.

PNVC Perham wanted clarification of the Department's actions concerning dealing with Posts in this type of situation. Lou Graham said he has new information of current Point of Contact for the North Troy Post.

Dept Cdr Tester reviewed upcoming events on this weekend's schedule.
