March is National Women's History Month, and there have been several articles and events

that have highlighted women veterans during the month. One of these exhibits is the "Color of



Freedom" at the Military Women's Memorial at Arlington National Cemetery. Check it out if you get a chance.

Being a Marine, one of my favorite female Marines is none other than Bea Arthur, who you may remember as Maude on the long running hit TV sitcom "Golden Girls". Bea served in the Marine Corps from 1944 to 1945 at USMCAS (US Marine Corps Air Station) Cherry Point, North Carolina, where she worked as a driver and a dispatcher. Upon her discharge in September 1945, **Arthur** had reached the rank of Staff Sergeant. SSGT Arthur, like the hundreds of female Marines before her, and the thousands that followed, blazed the trail and cracked the glass ceiling for Marines like myself.



The inclusion of women in the military not only gave birth to generations of women veterans, but a host of female Legionnaires as well. In honor of Women's History Month, I would like to highlight our three female Vermont Department Commanders.

The first female Department Commander was Marlys Ann (Pemberton) Lemnah elected Department Commander on June 26, 1997. Marty traveled around the State of Vermont raising funds for the Vermont Veterans Cemetery Chapel Building Fund.

Her countless hours of dedication made this a reality and provided families a place to hold services for their fallen veteran since November 1998.

The First Grenada/Panama and Desert Storm Veteran elected as Department Commander was Linda Thayer (Perham) on Jun 23, 2001. Linda and father PDC Wayne Mclean were the only father and daughter Department Commanders for over a century of American Legion History. Linda was appointed as the National Vice Commander for the Northeast Region in 2005. Linda continues to serve the Veterans as our current Department Adjutant, serves on the Board of the Dodge House and as adjutant of Rutland Post 31.

In June of 2007, Barbara (Whipple) Bushaw was elected as the third female Department Commander. Barb was a member of the Vermont National Guard for 21 years retiring with the rank of SSG.

Commander Barbara was, and still is, very active with the Legion serving on many Department committees.

I would like to thank these three trailblazing women, and all the female Legionnaire's in Vermont. Your hard work, dedication, and commitment to the veterans of our state have made our Department and your individual Post's a better place.

I look forward to seeing you at the Annual Department Convention which will be held June 25th and 26th at the Howe Center in Rutland.

Also on this web site is the application for the “Ron Aldrich Medal of Valor Award” which is for firefighters as well as EMT and Rescue personnel. Make sure you see that these are distributed to your local agencies. All award application have to be back to Department by April 15<sup>th</sup>.

RECONNECT: Thus far department representatives have attended four Vermont Air Guard deployments and one VTANG ceremony most recently in Bradford. Be advised that the department needs at least three (3) weeks lead time to procure blue star banners for award. We have had last minute calls resulting in our not being able to obtain nor present these banners. Please get the word out that we need “at least 3 weeks”.

We are into March and the winter is getting closer to an end (hopefully). While this month has a few religious holidays and a return to daylight savings time, it is most notable for the month with St. Patrick’s Day. However there is a date that is often forgotten by many, March 25<sup>th</sup>. This is National Medal of Honor Day wherein we honor those courageous members of our armed forces who have received this most prestigious award. One such individual was Audie Murphy. Thirty years ago this month I was at Arlington National Cemetery visiting the Tomb of the Unknown Soldier, and I found his gravesite nearby. The recognition of his gallantry was, and still is, inspiring. He was so much more than an actor in TV westerns.

The most recent recipient of this great honor was Army Staff Sergeant David Bellavia, an 11B, who is an Iraqi veteran who was in the battle of Fallu-

jah. The staff sergeant stated in part....”Why do American warriors under fire do what men have done since this nation’s inception? This is a common thread that connects the militias of Lexington and Concord with the warriors of Fallujah: It is our love of nation, our way of life, and our love by those we serve with side-by-side.....The best leaders in battle become that way by being loyal subordinates. We don’t get a vote. We execute the lawful intent of our government. There is no political affiliation on our dog tags. We continue the warrior legacy of the United States without regard for adulation or unanimous approval.....We’ve seen war. We don’t want war. But if you want war with the United States of America, there’s one thing I can promise you, so help me God - Someone else will raise your sons and daughters. We fight so our children will never have to (fight).”

His acceptance speech was inspiring, as our most recipients. I urge that you go on line and listen to some of these warriors and the heartfelt remarks that they make. Many are on YouTube.



Your Boys' State staff is marching ever forward! Progress report as follows:

1. Representatives Mike Marcotte and Patrick Seymour have drafted a resolution allowing GMBS to use the Vermont State House on Thursday, June 24<sup>th</sup> – with all safety guidelines in place at that time – for the In-Person Day at the Statehouse – If we are able! Their work has been signed off on by the SGT at Arms office.
2. Director Dave Cobb is making the final corrections and entries to the updated Vermont high school Counselor and guidance secretary list. We will utilize this list to electronically communicate with these members of their respective school staffs about Boys' State – there will be no paper communications for the 2021 year.

PS: This list is available for all American Legion – Department of Vermont programs and projects upon request.

3. GMBS staffer and alumni Dylan McNamara is heading his team to develop a schedule and programming for on-line version if we are unable to have an in-person program for this year. Dylan is a senior administrator in the Essex-Westford School District.
4. We are working with a Media / Communication consultant to review how, what, and when we communicate with schools. He is reviewing our current communications (all print) and will make suggestions on the use of social media and a redesign of print information and forms that will be made available through various electronic platforms. Did I mention that he's doing this for free??
5. Throughout the month of March, we will begin our outreach with schools and our Legion Posts as we look for our delegates for 2021
6. We are in fairly constant contact with our liaison at Northern Vermont University – Lyndon, our host site. Decisions on in-person programming for summer camps are slow to come, and somewhat extended by the new conversations around the State College System merger, but we are staying “in the game”.
7. There appears to be some new leadership at the National American Legion – Youth Advocate level. We have read the information put out so far, and will react and redirect as necessary and as possible. Hopefully, they will someday soon realize that not every program had 500 delegates and 100 staff members. Someday!
8. The 2021 budget for GMBS has been turned in for consideration at our upcoming meetings. It was based on the 2020 budget for an in-person program, with modifications and cutbacks in certain areas, based on the restrictions we see coming as we move forward.
9. The State of Vermont budget for FY '22 does contain an allocation of \$10,000 for the American Legion Boys' State and Legion Auxiliary Girls' State programs.

# Constitution and Bylaws

## Article V Constitution- Department Convention

### Section 6

**It now reads:** ...A quorum shall exist at the Department Convention when a majority of the Chartered Posts within the Department are present. When the Credentials Committee Chairman reports a Quorum, as set forth in the Bylaws of this Constitution, the Convention may transact any business before it.

**Proposed Change:** A quorum shall exist at the Department Convention when *forty percent (40%)* of the Chartered Posts within the Department are present. When the Credentials Committee Chairman reports a Quorum, as set forth in the Bylaws of this Constitution, the Convention may transact any business before it.

## Article II Bylaws Duties of Department Officers

### Section 6 Department Finance officer

**Now Reads:** The Department Finance Officer shall be the custodian of the funds of the Department, which he/she shall deposit in the name of the organization in banks insured by F.D.I.C., and/or invest in mutual funds or stocks as directed by the Finance committee with the approval of the Department Executive Committee not to exceed seventy-five thousand dollars (\$75,000.00).

**Proposed Change:** The Department Finance Officer shall be the custodian of the funds of the Department, which he/she shall deposit in the name of the organization in banks insured by F.D.I.C., and/or invest in mutual funds or stocks as directed by the Finance committee with the approval of the Department Executive Committee not to exceed *(50% percent of the fund balance on December 31<sup>st</sup> of the previous year).*

## Article III- Standing Department Committees

### Section 13: Law Cadet Training Committee

**It now reads:** The Department Commander shall appoint, subject to the ratification of the Department Executive Committee, at its first regular meeting following the Department Convention, five (5) members to the Cadet Law Enforcement Committee for a term of one (1) year. The Department Adjutant and the Department Finance Officer shall, in addition, be members of this committee with vote. The Department Finance officer shall handle all receipts and disbursement of funds connected with this program. They shall assist in the development of the program and shall cooperate with the Vermont State Police in the carrying out of its programs, schedules and training sessions as held at Vermont State Police Academy.

**Proposed change:** The Department Commander shall appoint, subject to the ratification of the Department Executive Committee, at its first regular meeting following the Department Convention, five (5) members to the Cadet Law Enforcement Committee for a term of one (1) year. *The Department Commander shall appoint*

a Chairperson of this Standing Committee from the 5 members whose term shall be for one (1) year. The Department Adjutant and the Department Finance officer shall, in addition, be members of this committee with vote. This committee shall develop and/or coordinate for an effective and appropriate Youth Law Cadet Program. The Department Finance officer shall handle all receipts and disbursement of funds connected with this program, and related program(s). The Department Commander, with the advice and consent of this committee, shall appoint a Director if necessary and required. This committee shall additionally review and evaluate all applications for the award of Law Enforcement Officer of The Year and complete the necessary evaluation forms for tabulation so as to discern the awardee who will be announced at the next annual convention. This committee will meet as often as necessary to properly perform its functions and on the call of the Chairperson.

### Vermont's 64<sup>th</sup> Oratorical Contest

On Saturday March 6, 2021 American Legion organizers, judges, candidates and audience members gathered at the Christ the King School gymnasium in Rutland, Vermont for the 64<sup>th</sup> Department of Vermont Oratorical Contest. Three contestants, Avery Carter (Manchester), Jeswin Antony (Waterbury) and Michael Christesen (Hanover), were on hand to be evaluated for their speaking talent, command of the subject matter, and presentation poise. These contestants were veterans of prior oratorical competitions and thus had a firm grasp on the nature of the proceedings and flow of events.

Miss Carter, sponsored by Crippen Fellows Post #50, delivered a well-constructed prepared speech about the famous Marbury vs Madison Supreme Court decision and its impact on the concept of judicial review. Mr. Antony, sponsored by Harry N. Cutting Post #59, proposed some interesting ideas in a talk entitled We the Cyberpatriots. Mr. Christesen, put forth by Lyman F. Pell Post #8, provided an in-depth review of the issues associated with universal, compulsory conscription.

Following their prepared remarks, the three contestants delivered a short three-to-five-minute extemporaneous talk about the 22<sup>nd</sup> amendment to the constitution. In all cases the contestants were extremely well spoken, thoughtful, factual and poised; bringing credit to themselves, their families and their schools. After suitable deliberation, the judges selected Avery Carter as the winner. Her third in as many years. For her victory at the State level, she was presented \$1000 by Commander Ron LaRose and a \$5000 award from the National American Legion organization in lieu of attending the national competition which has been cancelled due to the pandemic.

In addition to their placement awards, each contestant was presented a certificate from Senator Patrick Leahy commemorating their participation during this unusual time of social distancing and limited social interaction.

Congratulations are due to Karline DeVine, chair of the Oratorical Committee, and her team of experi-
