Dear American Legion Family Members and Friends,

March is Women's History Month. This is a time for us to recognize the women who have served in every war since the American Revolution, as well as make great improvements in the care for women veterans today and in the future.

Today, women are the fastestgrowing demographic in the military and veteran community – the number of women veterans is projected to be approximately 2.2 million in 2046. With this, VA must plan now to account for these demographic shifts and ensure that women veterans are provided high-quality care and resources.

Improved health care for women veterans is one of several <u>Ameri-</u> can Legion legislative priorities

for the second session of the 117th Congress. I testified on improved care for women veterans yesterday before joint session of the House and Senate Committees on Veterans' Affairs. An American Legion legislative victory for the first session of the 117th Congress was the passing of the Protecting Moms Who Served Act, which will improve maternal health care for women. Continued improvements in VA's reproductive care ensures that the needs of women veterans in areas of newborn, maternity and reproductive care are being met through comprehensive health services. This improved care will allow women veterans who seek health care through the VA feel that it is a system built with them in mind.

As we move forward in improved care for women veterans, it is important to advocate for new legislation which fills gaps remaining in care for our women veterans. This means improving mammography services (Making Advances in Mammography and Medical Options – MAMMO – for Veterans Act, S. 2533/H.R. 4794), mitigating the cost of contraceptive care, increasing access to childcare services and newborn care at VA medical centers, and studying the need for women-specific drug



and alcohol dependency rehabilitation programs (H.R. 344, Women Veterans TRUST Act), as well as others.

This is also includes addressing gender-specific difficulties that affect women veterans, such as not being recognized as a veteran by VA employees, lack of awareness and understanding of VA health-care benefits, and that women veterans being more likely to experience mental health issues and military sexual trauma, as well as chronic pain management and musculoskeletal condition treatment. To address these problems and barriers to care, VA must have care models and standards that are gender-specific and culturally competent. As women remain the fastest growing veteran demographic, The American Legion will continue to advocate for Congress and VA to meet the unique medical needs of women veterans. A veteran is a veteran, so let's stand ready to care for and meet the needs of our women veterans and recognize the sacrifices they have made by improving their care.



SWOT is an acronym used to denote Strength, Weaknesses, Opportunities, and Threats. It is utilized in what is called SWOT Analysis. It is both a planning and assessment tool. This is a technique developed at Stamford in the 70's and is frequently used in strategic planning and at times being very situational. It is a very much structured method with which to plan that evaluates those four elements of an organization, project, event, etc. It is a powerful framework for leveraging and/or identifying an organizations strengths, identifying and

improving weaknesses, identifying and minimizing threats, and taking full advantage of opportunities. It is definitely a powerful problem solving method with the end result being a viable plan for improvement. I have utilized this framework numerous times working with staff to effectively problem solve or to reinvigorate a stalled course of action.

Why am I bringing this up in this forum? It is applicable to the American Legion Posts or even membership. Well, let's take a look at the process:

- List all strengths now. Then, list all the weaknesses.
- List all opportunities, current and in the future. Then list the future weaknesses. (Threats are potential future weaknesses.
- Plan of Action Review you

matrix with an eye to formulating an action plan to address each area.

Where does all this take us ..... Strengths need to be maintained Weaknesses and built upon. need to be stopped or at the very lease reduced to the lowest level possible. Opportunities need to be optimized and definitely need to be prioritized. Threats need to be countered with alternatives or minimized to the full extent possible. The following is a very rudimentary matrix for membership. It can be expanded on and utilized as planning tool to identify post membership needs..... Be creative and go for it.

# Free Entrance Fees for Veterans and Dependents

Entrance fees for the National Park Service and the U.S. Fish and Wildlife Service and standard amenity recreation fees for the Bureau of Land Management, Bureau of Reclamation, U.S. Forest Service and U.S. Army Corps of Engineers sites **are waived for current Military Service-members and their dependents, Veterans and Gold Star Families.** 

They now have free access to approximately 2,000 public locations spread out across more than 400 million acres of public lands, which host activities to fit any lifestyle, from serene to high octane, including hiking, fishing, paddling, biking, hunting, stargazing, camping, and much more.

## Are you eligible?

For purposes of this program, a Veteran is identified as an individual who has served in the United States Armed Forces, including the National Guard and Reserves, and is able to present one of the following forms of valid (unexpired) identification:

Department of Defense Identification Card

Veteran Health Identification Card (VHIC)

Veteran ID Card

Veterans designation on a state-issued U.S. driver's license or identification card Gold Star Families are next of kin of a member of the United States Armed Forces who lost his or her life in a "qualifying situation," such as a war, an international terrorist attack, or a military operation outside of the United States while serving with the United States Armed Forces.

# The America the Beautiful – the National Parks and Federal Recreational Lands Pass (Interagency Pass) Program

The Interagency Pass Program already includes a free annual pass for active duty members of the U.S. Military and their dependents. Current Military Service-members must show a valid (unexpired) Department of Defense ID. Dependents of current Service-members must show a valid (unexpired) DD Form 1173 AD or DEC.

The annual Military Pass has been expanded to include Veterans and Gold Star Family members. Other free or discounted passes, including some lifetime passes, are available for persons with permanent disabilities, fourth grade students, volunteers, and senior citizens age 62 years or older.

## How to get your Interagency Pass

Interagency Passes can be obtained in person while visiting a participating site. Visit Places to Get Interagency Passes for a searchable list and be sure to contact the site before you go, to make sure they are open and have passes in stock. In addition, Military passes, as well as those for seniors and persons with permanent disabilities, are available online through the USGS Online Store.

For more information about eligibility and passes, visit Free Entrance to National Parks for Veterans and Gold Star Families (U.S. National Park Service) (nps.gov).

The participating agencies also offer several fee-free days for everyone throughout the year to mark days of celebration and commemoration. Examples of fee-free days include the birthday of Martin Luther King, Jr., National Public Lands Day, Veterans Day, and the signing of the Great American Outdoors Act.

Fee-free days and fee policies vary among the agencies, so it's best to check the agency website or contact the site you plan to visit in advance of your trip.

## **Mid-Winter Conference: A Busy Time**

At the Mid-winter Conference in January I thought it would be an interesting exercise to trail along with the Department Commander to gain a perspective on the variety of activities that consumed her time and attention. I found the experience enlightening, informative and well worth the effort. What follows is an abridged version of her very active schedule.

#### Friday, January 21st

After checking in with the registration personnel and attending to some last minute details the Commander then dropped in on several committee meetings that were scheduled for the day.

**1000 hours**- Conference Convention Committee: listened to a proposal by Barre Post #10 to host the Annual Convention in June. Lots of good questions regarding capacity, parking, and hotel accommodations were asked. Further investigation suggested. Also, there was discussion about the location for the January 2023

## Department of Vermont Oratorical Program 2022 Department Finals



2022 Vermont Department Oratorical Finals. Runner up (L) Michael Christesen, (middle) Commander Tester, First Place (R) Jeswin Antony. This is the third Department Finals for each of these students.

In the auditorium of the Pavilion in Montpelier, Jeswin took 1<sup>st</sup> Place with his Prepared Oration, "We, the Cyber Patriots", proposing a 28<sup>th</sup> Amendment to discourage misinformation, bullying, and abusive practices on the internet. He reflected that he has two younger brothers lacking understanding and familiarity to manage some information and misinformation available on the Internet. In defense of appearance of "intrusion of privacy," Antony noted that Transportation Security Administration (TSA) requirements impact personal privacy for safety of others in the air flight encounter.

The Prepared Oration and Assigned Topic are scored on many factors related to minutes taken to deliver the speech, content and speaking skills. The oration is given without use of a microphone, podium, or notes.

The Assigned Topic is one of four chosen by National in May 2021. The Assigned Topic of the day is chosen by random draw and given to the student with 5 minutes to prepare to speak. This year's selection was Amendment XIV, Section 3 which prohibits any person who had gone to war against the union or given aid and comfort to the nation's enemies from running for federal or state office, unless Congress by a two-thirds vote specifically permitted it.

Jeswin will represent Department of Vermont at the National Oratorical Finals, April 22-24 in Indianapolis, IN. For Jeswin and his father, Antony Gnanapiragasam, travel and room expenses are reimbursed by the National American Legion.

Jeswin is a resident of Waterbury, VT and is a junior at Harwood Union HS. He was sponsored by Post 59 in Waterbury, VT and received awards from Post 59, District 3 and \$1500 from the Department. The National Winner receives \$25,000, second and third place receives \$22,500 and \$20,000 respectively. Each Department winner who is certified and participates in the First Round will receive a \$2,000 scholarship. Each First Round Winner who participates in the Second Round, but does not advance to the Finals, will receive an additional \$2,000 to pursue education beyond high school.





# **COMMANDER'S**

**PROJECT**

**Project:** To build a permanent structure to house the original chapel bell at the Vermont Veterans Home.

- Goal: To raise \$15,000.00 for this project.
- **History:** The Vermont Veterans Home came into being in 1884. In 1890, a chapel was built entirely with donations from the Grand Army of the Republic. The bell for the chapel was donated by Major A. B. Valentine, a prominent businessman in Bennington at this time.

During the period 1967 - 1976, several renovations and building projects were completed and the original chapel was taken down. A new chapel was built along with a large community room. The Chapel Bell was kept but not built into the new chapel. Instead, it was affixed to a 4' high wooden post structure and parked outside the chapel building. Over the years, the Bell had rusted badly and was in poor condition.



In 2016, the Bennington Rotary Club arranged for the Bell to be refur-

bished. The metal pitting was repaired, and the Bell proper was repaired and resurfaced. However, it still resides atop the 4' wooden posts and is now placed at the memorial area on the Home grounds. This method of display leaves the Bell open to the elements and more evidence of metal pitting and deterioration of the Bell proper is occurring.

**The Plan:** The project entails the Bell being removed from the wooden posts and placed in a permanent structure that would protect it from the elements and place it on display with a plaque giving the history of the Chapel Bell.

The structure will be placed in the grassy area just in front of the main entrance of the Veterans Home and resemble the original architecture of the Veterans Home.

The Bell would be hung inside the structure rather than set on a base.

A stamped concrete walkway would lead to the Bell display with a wrought iron fence around the structure.

Local contractors have already been contacted and have signed on for the project.

# PathwaysVermont 2021 FACT Supportive Services for SHEET Veteran Families

In partnership with



The Supportive Services for Veteran Families (SSVF) program is a national initiative funded by the Department of Veterans Affairs to address homelessness among veterans in the United States.

The SSVF program is housed in Vermont Veteran Services at the University of Vermont, with case management and housing services provided by Pathways Vermont. The program helps very-low income veteran households who are homeless or imminently at risk of homelessness gain and retain stable housing.

Services provided include needs assessment, intensive housing case management, assistance accessing VA benefits and financial assistance.

#### PROGRAM SERVICES

The Supportive Services for Veteran Families program provides short-term supportive services to participants to help them obtain and/or retain stable housing in 90 days. The program uses a Rapid Rehousing approach, meaning the program's priority is to support participants in developing a permanent housing option.

Intensive case management is the primary service provided. In certain cases, case management may be augmented by temporary financial assistance. This assistance is used to help with expenses related to securing housing, for example rental assistance, security deposits, utility deposits and other related expenses. It should be noted that financial assistance is limited in amount and cannot be guaranteed.

#### FY22 FUNDING

In 2014 Pathways Vermont was awarded a subcontract from SSVF at UVM to provide case management and housing services for a Supportive Services for Veteran Families grant awarded by the Department of Veteran Affairs. The SSVF program operates in all 14 counties in Vermont and 6 counties in the eastern Adirondacks. We have to raise \$15,000 to cover expenses that the grant does not cover.

A Vermont State program to incentivize non-Recruiters to become a Recruiting Assistant by supporting the enlistment / accession of Soldiers or Airmen into the VTNG.
