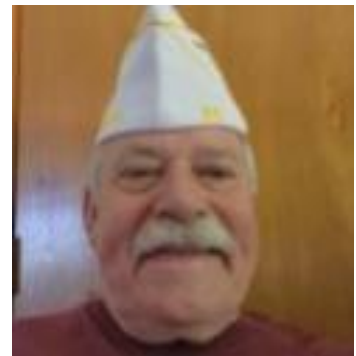
### **Southern Area Commander – Fred Wilson**

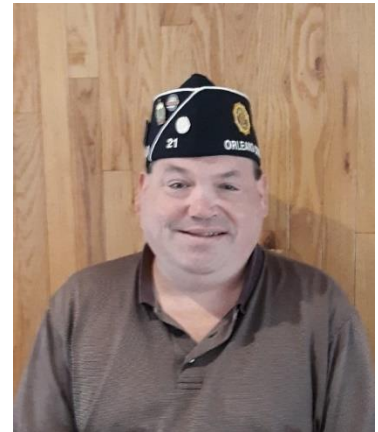

### **Legislative Chairman – PDC Richard “Dick” Farmer**

The Vermont Legislation has been in session since the beginning of January. There has been progress made for retired military tax exemption. Rep. Canfield rewrote his bill and resubmitted it. The new number is H.43.

The bill “progress to exempt military retirement and survivor benefit income CH43 Canfield. It must be stated this bill has over seventy endorsements, Democrats, Independents and Republicans.

Governor Scott has made mention of tax exemption for retired military in his State of State of Address. He is for the bill and has built in any that may be lost in the early years.

I attended a hearing on Bill H43 on 31 January 25. The bill was presented very well and it was well received. There seems to be some confusion on the military Affairs Committee that only a retired Veteran would be eligible. This would affect 3,900 not 40,000

What can we do. Again, talk to our Representatives. Let them know how this would help the retired military Veteran.
