Greetings Legionnaires,

There are two items I'd like to offer this month.

The first is that it is now "Installation Season". Many Posts have held elections of officers, or are in the process of doing so. Those officers need to be installed. Lyndon Post 30 was installed on 1 May and Hardwick Post 7 is scheduled for 19 May. Until Convention on June 23-26, 2<sup>nd</sup> District Posts may feel free to contact me to schedule installations via email (preferred) at trollfur@yahoo.com or by phone at 802-272-0416. After Convention, you will have a new 2<sup>nd</sup> District Commander, as I am running for Northern Area Commander.

The second item:

As we all know (or should...), meetings of The American Legion are governed by Robert's Rules of Order.

I would therefore like to offer a little bit of education on Parliamentary Procedure.

One of the most misused, abused and "weaponized" motions that I have seen used in recent history at our meetings, be they at Posts, Department Executive Committee, or Conventions, is the motion "to Call the Question," which has the technical name of "Move the Previous Question" in Robert's Rules of Order. It is very common for people to shout out the word "question" or "I call the question" in the expectation that debate will immediately stop, and a vote will be taken. This is NOT CORRECT.

#### THINGS TO KNOW ABOUT "CALLING THE QUESTION"

1. A member must have the floor in order to make this motion. Raise your hand and wait until the chair gives you the nod – "recognizes you" – before speaking.

2. When you make this motion, you are only suggesting that YOU would like to stop debate and vote. It is an expression of your wish, and nothing more.

3. This motion requires a second. There have to be at least two people in the room who want to cut off debate before it can be considered.

4. This motion cannot be discussed or debated. As soon as the chair hears a second, they immediately take the vote. 5. It takes TWO-THIRDS of the voting members in favor to cut off debate. Therefore, the chair should take the vote by show of hands, and not by voice.

6. If indeed two-thirds of the group want to stop debate and vote, then the chair immediately takes the vote on the pending motion – the motion that the group is considering at this time. No further discussion is allowed.

That is it in a brief form. For more detailed information on this particular motion, which takes up a lot more room than I have here, I would refer you to Roberts Rules of Order, Newly Revised, 12<sup>th</sup> Edition, Section 16.

Because the "weaponization" of this motion stifles healthy debate and prevents opposing views from being heard, I'll also refer you to Roberts Rules of Order, Newly Revised, 12<sup>th</sup> Edition, Section 23 for "Point of Order", which you will be hearing me shout whenever I hear the "Call the Question" motion being misused in the future.

# The Department of Veterans Affairs (VA) announced the addition of nine rare respiratory cancers

The Department of Veterans Affairs (VA) announced the addition of nine rare respiratory cancers to the list of conditions <u>presumed to be service-connected</u> due to military environmental exposure to fine particulate matter.

VA determined through a focused review of scientific and medical evidence there is biological plausibility between airborne hazards, specifically particulate matter, and carcinogenesis of the respiratory tract, and that the unique circumstances of these rare cancers warrant a presumption of service connection.

Based on these findings, VA published an interim final rule establishing presumptions of service connection for several rare respiratory cancers for certain Veterans. These cancers include:

- Squamous cell carcinoma of the larynx;
- Squamous cell carcinoma of the trachea;
- Adenocarcinoma of the trachea;
- Salivary gland-type tumors of the trachea;
- Adenosquamous carcinoma of the lung;
- Large cell carcinoma of the lung;
- Salivary gland-type tumors of the lung;
- Sarcomatoid carcinoma of the lung; and
- Typical and atypical carcinoid of the lung.

The rarity and severity of these illnesses, and the reality that these conditions present a situation where it prompted us to take action. We are utilizing a new approach, one that takes all available science into account, with one goal in mind— getting today's Veterans—and Veterans in the decades ahead—the benefits they deserve, as fast as possible. We are fulfilling our promises to provide more care, more benefits and more services to more Veterans than ever before.

VA focused its rule on the rare respiratory cancers above for Veterans who served any amount of time in the <u>Southwest Asia theater of operations and other locations</u>. VA invited and will consider public comments as part of this process.

National Executive Committeeman, by virtue of his/her office, shall be a delegate to the National Convention.) (Section III, Article VII, National Constitution & By-Laws.)

To transact such other business as may be legally brought before the Convention.

## REPRESENTATION

Shall be by Posts in accordance with Department Constitution & By-Laws, Article V, Page 9.

**ARTICLE V – Section 3.** A Department Convention shall be composed of delegates and alternates chosen annually by each Post, each of which shall be entitled to one (1) delegate and one (1) alternate for each twenty-five memberships or major fraction thereof, paid to the Department Finance Officer, 45 days prior to the date of the opening of the Department Convention. Delegate strength to be based on membership on file at Department Headquarters 45 days prior to the opening date of Department Convention. Membership received following the 45-day period at Headquarters Office shall not be used in determining Post delegate strength. In addition, each Post shall be entitled to one (1) delegate and one (1) alternate at large. All Past Department Commanders and current Department Officers and current elected National Officers, while in good standing in their respective Posts, shall be delegates to the Department Convention with vote, to be exercised with their respective Posts, such votes thereof, shall be in addition to the number of delegates allowed said Posts as provided in this section.

Section 4. Each delegate shall be entitled to one vote. Alternates shall have all the privileges of delegates and shall vote only in the absence of the delegate. No voting by proxy shall be allowed.

Section 5. The Posts shall elect all delegates and alternates not less than thirty (30) days prior to the opening date of the Department Convention.

**Section 6**. A quorum shall exist at Department Convention when (40%) of the Chartered Posts within the Department are present. When the Credentials Committee Chairman reports a Quorum, as set forth in the Bylaws of this Constitution, the Convention may transact any business before it.

**Section 7**. The Department Convention Committee, i.e., Resolutions, Credentials, Distinguished Guests, and/or any other Committee that may be deemed necessary to conduct a Department Convention, shall be appointed by the Department Commander, not less than fourteen (14) days prior to the opening date of the Department Convention. Only accredited delegates to the Department Convention shall be eligible for appointment to any Convention Committee. The Standing Committee on Constitution and By-Laws shall constitute the Constitution and By-Laws Committee at the Department Convention.

## CREDENTIALS

Attention of all Posts is called to the resolution relating to delegates and alternates passed by the 1936 Department Convention, reading as follows:

**RESOLVED,** that it is the sense of this Convention that delegates and alternates presenting themselves to the Committee on Credentials for seating shall, in addition to complying with present regulations, be required to present to the Committee on Credentials their Membership Card, or having failed to bring such card, shall furnish to the Committee other evidence sufficient to satisfy such Committee, that they are members in good standing of the Post they propose to represent;

AND BE IT FURTHER RESOLVED, that it is a sense of this Convention that all persons entering the

Convention Hall at or for any of the business sessions of the Department Convention, shall be required to show their Membership Cards before being allowed to enter.

#### IT IS IMPERATIVE THAT ALL DELEGATES ARE INSTRUCTED TO HAVE THEIR LEGION MEMBERSHIP CARD, FOR THE CURRENT YEAR (2022), WITH THEM AT CONVENTION.

THEIR LEGION MEMBERSHIP CARD MUST BE SHOWN ON SATURDAY, JUNE 25, 2022. NAME CONFIRMATION FROM DELEGATE SHEET WILL ALSO TAKE PLACE SO THAT HE/SHE MAY BE SEATED IN THE VOTING SECTION OF THE CONVENTION.

## **DISTRICT MEETING**

District Commanders may call a meeting of the delegates and alternates from their respective districts, at such time and place as will not conflict with the Convention Program.

## RESOLUTIONS

Posts having resolutions to present to the Convention are required to send one (1) typewritten copy of each resolution to the Department Adjutant, Department Headquarters, P O Box 396, Montpelier VT 05601-0396, two (2) weeks PRIOR to the opening date of the Department Convention.

## **AMENDMENTS – DEPARTMENT CONSTITUTION**

**ARTICLE XIV, Section 1 (PAGE 20)**. The Department Constitution may be amended at any Department Convention by a two-thirds vote of the total delegates thereat; provided that the proposed amendments shall have been sent to all Posts and members of the Department Executive Committee at least thirty (30) days prior to the opening date of a regularly called Department Convention.

Section 2. That no proposed amendment shall be submitted through the Department Adjutant to the several Posts, as provided in Section 1 of this article, unless said proposed amendment shall have been first submitted by a Post, the Department Executive Committee, or by the Constitution and By-Laws Committee of The American Legion, Department of Vermont, Inc.

**Section 3**. Any provisions of this Constitution shall be automatically amended to conform to any amendment adopted by The American Legion, at its National Convention, to the National Constitution of The American Legion, when said amendment affects that Department or its internal organization.

Section 4. Any amendment to this Constitution shall be effective at the close of the Department Convention, at which the same is adopted.

# A WAY IN THE WILDERNESS

I drove my government-issued truck into the desert to visit a Marines unit, the familiar cammie netting assuring me: Your people are here. A high-ranking enlisted leader had requested to talk to a chaplain. We found a rare patch of shade, sat in the dirt, and laughed a little as we called it my office.

The Marine said he was going through a tough time and needed to vent to a chaplain's confidential ear. But I heard a story that was beyond "tough." He told me what he had witnessed and done to protect others—tasks no Marine would ever wish upon another—things that still haunt him. He told me that sleep deprivation was catching up; how many Marines count on him; how he needs a break but can't ever take one.

I took in both the nobility of this man and how the weight of that nobility could soon break him, putting himself and his Marines at risk. I assured him that if he just wanted to trust me with his secrets, I would take them to my grave. However, I recommended something very different: to talk to his leadership about sending him home to get help. We talked about how this would look weak to the Marines he supervises, but how he could also set an example of what it means to ask for help.

He asked me to be with him as we asked his chain of command for their support.

An hour later, a senior-level command team member called me: he disagreed with me, and assured me the Marine would not come home.

I told him that it's his job to make that call, and my job as a chaplain is to inform him when I think the command is assuming an excessive level of risk. As long as you make informed decisions about the risk, I told him, then my job is done. He said he would think about it.

The next morning I was informed that the Marine was flown home.

Military professionals need to remain mission-focused. Military chaplains are there to remind leaders that none of us are mission-making machines. The military teaches us that no matter how technically or tactically proficient we are, we are all replaceable. It's a gift to know none of us are so special and none of us are so alone.

## Army Reserve Ambassador Emeritus for New Hampshire

Dear Vermont AL Department):

I believe that you are the current Commander of the American Legion, VT Chapter and am looking for your help.

I am presently serving as the United States Army Reserve Ambassador-Emeritus (USAR) for NH and have been asked to reach out to try to find Ambassador candidates in Rhode Island and Vermont. My thinking is that the best place to go would be our sister American Legion chapters in those states. Vermont was previously represented by John **Des Groseilliers from Hard**wick. John passed over a year ago and AR command is seeking a replacement. Perhaps you know of potential candidates. Vermont is assigned one **USARA**.

Essentially, an Army Reserve Ambassador post is an appointed voluntary position with a goal to maintaining Army Reserve contacts in their home states of soldiers and spreading the Army Reserve message generated by the Commander of the Army Reserve in Washington. In the Northeast from Maine to Virginia, we align ourselves 99<sup>th</sup> Training Battalion out of Fort Dix. The current Army Reserve Ambassador for NH is James Steiner who succeeded me when I was made "Emeritus."

Since, the current Army Reserve force is presently is a very diversified group of soldiers, candidates are welcomed to come from all walks of life. Any citizen eager to put some volunteer time in to help Army Reserve soldiers can be qualified. Prior Military Service is not required but helpful. A motivated civilian who wants to put in the time can come up to speed quickly. As an example, while I previously served in public office, I did not serve in the military and have been an Army Ambassador for over 12 years. We generally look for 2-3 potential candidates for the selection committee.

Here is my personal thoughts on Skills needed for and Army Reserve Ambassador: 1) A current knowledge or learned knowledge of elected leaders in your state is helpful along with the willingness to go meet those leaders where possible along with their staff. Included are leaders at the Federal, state and municipal levels. This knowledge is helpful when the local ARA is called upon to arrange for meetings when the Commanding General or subordinate from the 99<sup>th</sup>, who may make the rounds to introduce themselves and tell elected leaders how they can help AR soldiers and advise state and federal leaders how the AR can help them in times of crisis or disaster; 2) A willingness to speak before groups to encourage recruiting,

further the AR message including the availability of scholarships and the like. 3) The willingness to help soldiers and their families wherever they can. 4) A Willingness to attend periodic training and informational conferences at Ft. Dix, Washington or elsewhere. These are covered expenses; 5) Willingness to visit AR facilities in state and meet with soldiers to assist with morale and show that we car; 6) Numerous self-initiated activities. This is a position that requires the Ambassador to be selfinitiated with quarterly reporting of activities to our coordinator at the 99<sup>th</sup>.

The position is a good way for someone to get to know the state and contribute a lot to soldiers and their families. I have found it to be an interesting and rewarding endeavor.

Please give me a call when you can to confirm the current officers of the Vermont Department and advise who else you feel that I should reach out to.

I look forward to hearing from you.

"Because I said so!" won Emma Noble of Alabama, \$25,000 at the National Finals of the American Legion Oratorical Program. "The Power of Executive Orders: Because I Said So!" was the title of her winning speech. Emma characterized a Presidential Executive Order as a "Because I said so" from the President of the United States. Putting an Executive Order into effect does not involve an "act of Congress" thus requires less time to put it into effect. She educated the audience to the fact that executive orders were used to expand the National Parks system, expedite construction of the Panama Canal, desegregate the military in WWI, and establish Japanese internment camps during WWII. The Emancipation Proclamation was an executive order.

Between President Theodore Roosevelt and President Harry Truman, an average of 206 executive orders were given annually. More recently, Presidents Bush, Obama and Trump issued an average of 260 executive orders annually. Following a directive from a parent for "because I said so" is dependent on trust. "Knowing that Presidents have the power of executive orders means that voters must be able to trust their candidate's potential executive orders." Emma closed her speech in 9 minutes and 59 seconds by reminding the audience that it is a citizen's responsibility to their country to be an informed voter and select the candidate they can trust with the executive order privilege.

# **COMMANDER'S**

PROJECT

**Project:** To build a permanent structure to house the original chapel bell at the Vermont Veterans Home.

- Goal: To raise \$15,000.00 for this project.
- **History:** The Vermont Veterans Home came into being in 1884. In 1890, a chapel was built entirely with donations from the Grand Army of the Republic. The bell for the chapel was donated by Major A. B. Valentine, a prominent businessman in Bennington at this time.

During the period 1967 - 1976, several renovations and building projects were completed and the original chapel was taken down. A new chapel was built along with a large community room. The Chapel Bell was kept but not built into the new chapel. Instead, it was affixed to a 4' high wooden post structure and parked outside the chapel building. Over the years, the Bell had rusted badly and was in poor condition.



In 2016, the Bennington Rotary Club arranged for the Bell to be refur-

bished. The metal pitting was repaired, and the Bell proper was repaired and resurfaced. However, it still resides atop the 4' wooden posts and is now placed at the memorial area on the Home grounds. This method of display leaves the Bell open to the elements and more evidence of metal pitting and deterioration of the Bell proper is occurring.

**The Plan:** The project entails the Bell being removed from the wooden posts and placed in a permanent structure that would protect it from the elements and place it on display with a plaque giving the history of the Chapel Bell.

The structure will be placed in the grassy area just in front of the main entrance of the Veterans Home and resemble the original architecture of the Veterans Home.

The Bell would be hung inside the structure rather than set on a base.

A stamped concrete walkway would lead to the Bell display with a wrought iron fence around the structure.

Local contractors have already been contacted and have signed on for the project.

# PathwaysVermont 2021 FACT Supportive Services for SHEET Veteran Families

In partnership with



The Supportive Services for Veteran Families (SSVF) program is a national initiative funded by the Department of Veterans Affairs to address homelessness among veterans in the United States.

The SSVF program is housed in Vermont Veteran Services at the University of Vermont, with case management and housing services provided by Pathways Vermont. The program helps very-low income veteran households who are homeless or imminently at risk of homelessness gain and retain stable housing.

Services provided include needs assessment, intensive housing case management, assistance accessing VA benefits and financial assistance.

#### PROGRAM SERVICES

The Supportive Services for Veteran Families program provides short-term supportive services to participants to help them obtain and/or retain stable housing in 90 days. The program uses a Rapid Rehousing approach, meaning the program's priority is to support participants in developing a permanent housing option.

Intensive case management is the primary service provided. In certain cases, case management may be augmented by temporary financial assistance. This assistance is used to help with expenses related to securing housing, for example rental assistance, security deposits, utility deposits and other related expenses. It should be noted that financial assistance is limited in amount and cannot be guaranteed.

#### FY22 FUNDING

In 2014 Pathways Vermont was awarded a subcontract from SSVF at UVM to provide case management and housing services for a Supportive Services for Veteran Families grant awarded by the Department of Veteran Affairs. The SSVF program operates in all 14 counties in Vermont and 6 counties in the eastern Adirondacks. We have to raise \$15,000 to cover expenses that the grant does not cover.
